THE CHANGES IN THE WHO'S HEALTH REGULATIONS

The World Health Organization (WHO) is about to achieve an international agreement that will dissolve national sovereignty and replace it with a global medical and financial dictatorship, that will take away the national independency of the member states, the authority of the individual state and the people's immensely valuable right to privacy regarding health matters and the freedom to travel.

The International Health Regulations Review Committee (IHRR) in the WHO has met in secret to finalize a 46-page document that includes proposed changes in the International Health Regulations (IHR).¹

The International Health Regulations is an existing, legally binding international law. If the proposed changes will be presented to the 76th World Health Assembly (Sunday, May 21 to May 30, 2023), they can be adopted by a simple majority of the 194 Member States and will be legally binding for all.

SUPRANATIONAL INTERNATIONAL DICTATORSHIP

The proposed changes will:

1. Change the overall nature of the WHO from an advisory organization that only gives recommendations, to a governing body whose proclamations will be legally binding. (Article 1)
2. Give the Director-general of the WHO the control of the means of production through an "allocation plan for health products" to request developed countries to deliver pandemic response products as directed. (Article 13A)
3. Seek to remove the "full respect for the dignity, human rights and fundamental freedoms of persons". (Article 3)
4. Redirect unspecified numbers of billions of dollars to Pharmaceutical Hospital Emergency Industrial Complex without accountability. (Article 44A)
5. Give the WHO authority to require medical examinations, proof of prophylaxis, proof of vaccination and to implement tracing of contacts, quarantine and TREATMENT. (Article 18)
6. Considerably expand the WHO's authority to censor what they regard as misinformation and disinformation. (Attachment 1, page 36)

According to the already adopted rules by the IHR, if the proposed changes are adopted the Member States don't need to take further actions. If adopted, the proposed changes will be legally binding for all Member States, regardless of whether the delegates from each country vote for or against adopting them.

What will happen after this? Then there will probably be another pandemic. The WHO will then demand that everyone must follow the new global laws, and that everyone must take new injections with unsafe, insufficiently tested and dangerous ingredients, which will cause lots of side effects and maybe even more. They will also demand everyone to have a vaccine passport. And how will it go with those who don't want to take the new injections? They'll have to sit at home, not go to work with others, not take the bus, not go to shops, they may even have to pay fines and be punished in some or another way. This seems to be the results of the WHO's medical dictator recipe. We are NOW entering this era of global dictatorship! My friend, what will you do? It is your body and your future that is at stake. Should other people decide and rule over your body?
